Does immigration status affect participation in the Save to College Program?

It does not. Families do not need to provide a social security number to be enrolled Into the program.

What happens if students move to another school or leave the NYC public school?

Once the child receives a NYC Scholarship Account, they will continue to have access to the account. They will be eligible to earn additional benefits and rewards.

Can money in an NYC Scholarship Account be used for education aboard?

Yes, the account can be used for qualified higher education expenses at any eligible institution in the US and abroad.
