Title: Request for Quarterly Reports on Capital Projects in District 24

Whereas, The Community Education Council for District 24 (CEC24) is committed to ensuring that all stakeholders, including students, families, and school communities, are well-informed about capital projects that impact their educational environment;

Whereas, CEC24 has observed a lack of communication and transparency regarding ongoing and proposed capital projects within District 24, which affects the ability of the CEC, the District 24 office, and individual school administrations to effectively serve and advocate for their communities;

Whereas, Timely and accurate information about capital projects is crucial for planning, safety, and the overall well-being of students and staff in District 24;

Therefore, be it resolved, that CEC24 formally requests the School Construction Authority (SCA), the Department of Education (DOE), and any other relevant agencies to provide a comprehensive quarterly report on all capital projects within District 24;

Be it further resolved, that these quarterly reports shall include, but not be limited to, the following information:

- A detailed list of all ongoing and proposed capital projects within District 24, including project descriptions, locations, timelines, and expected completion dates;
- The current status of each project, highlighting any delays, changes in completion dates, or alterations in project scope;
- A summary of any issues affecting the school community, including, but not limited to, life safety hazards such as the activation of fire alarms with false alarms, disruptions to school operations, or other safety concerns;
- Contact information for the project managers or other responsible parties for each project;

Be it further resolved, That CEC24 shall receive these quarterly reports no later than the 15th day of the month following the end of each quarter (i.e., January 15th, April 15th, July 15th, and October 15th), and that these reports shall be promptly posted on the CEC24 website to ensure that the District 24 community is fully informed about the projects occurring in their children's schools;

Be it finally resolved, That having this information readily available will assist CEC24 members in staying informed and actively participating in discussions related to the five-year capital plan, thereby enhancing their ability to advocate effectively for the needs of the District 24 community.
